Health & Safety Data

Due to the presence of sodium nitrate and sodium nitrite, which are hazardous materials, great care should be taken in the handling of this product to avoid all possibilities of ingestion, inhalation and skin or eye contact. Both sodium nitrate and sodium nitrite are toxic if swallowed or inhaled and can give symptoms of nausea, headache, dizziness, weakness, abdominal pains or shortness of breath, etc.; if ingested, induce vomiting and give plenty of water to drink, treat as for shock and seek medical assistance.
