## Product Specification and Technical Information:

- 1 **<u>Product Description</u>**: Edible Bovine Collagen Casing (SELECT-F & SELECT HANDLINK) supplied as a tubular compressed strand.
- 2 **<u>Product Application</u>**: For use in the manufacture of fresh sausages.
- 3 **<u>Product Composition:</u>** Bovine Collagen (UK/Ireland), Water, Glycerol, Poly-1-Decene, Sodium Carboxymethyl Cellulose, Acidity regulator (Calcium Acetate).
- 4 **Labelling Advice:** The responsibility for the labelling of the sausage lies with the producer. Under EU legislation the casing can be labelled as either *Edible Beef Protein Casing* or *Edible Bovine Collagen Casing*. The other components of the casing have no function in the final product, the sausage, and should not require labelling; this advice is based on Regulation (EU) 1169 / 2011.

## 5 **Physical Attributes (Each product is supplied with a unique 16 digit product identification code):**

Flat width = target +/- 0.75mm Strands per box = as specified Average box length= as specified End closure= as specified

- 6 Microbiological: Salmonella Absent in 25g under the Regulation (EC) No 2073/2005 (as amended).
- 7 <u>Heavy Metals:</u> Legislative residue limits required under the Regulation (EC) 853/2004, collagen fit for human consumption
- 8 **Shelf Life:** 2 years from date of manufacture.
- 9 <u>Storage:</u> Store in a cool dry place avoiding extreme temperature variations. Boxes should be retained in sealed wrapping film and only opened immediately prior to use.
- 10 **Packaging:** Food contact approved boxes. Boxes sealed and foil wrapped in a modified atmosphere and packed in shipping cartons.
- 11 <u>Health and Safety Information</u>: The product as supplied does not constitute any known hazard to health. No special handling requirements are necessary.
